To All VT Medicaid EHR Incentive Program Providers and Preparers:

*** Program Year 2013 is closed, and MAPIR is now available for Program Year 2014 applications for all Eligible Professionals and Eligible Hospitals**

Congratulations to all Eligible Professionals and preparers who successfully submitted EHR Incentive Program applications for Program Year 2013! We saw an unprecedented number of applications submitted as both VITL staff and the EHRIP Team were very busy resolving all kinds of questions before Program Year 2013 drew to a close on midnight 4/1/14. More than **260** applications were submitted in the final two weeks of the grace period window! If you did not meet the deadline to apply for Program Year 2013, the good news is that you will be able apply for Program Year 2014, which is now available to **ALL** Eligible Providers with the completion of the upgrade to our MAPIR system today.

In the coming weeks, the EHRIP Team will be reviewing applications in the order they were submitted, and will be engaging with providers and preparers as necessary in the course of our validation procedures.

*** Updated User Guides**

Eligible Professionals should download the new User Guide to accompany the latest version of MAPIR 5.3. New Stage 2 components and screen configurations are included in the updated User Guide. *** Program Year 2014 Certified EHR Systems**

In order to apply for a Program Year 2014 EHR Incentive Payment, you need to be utilizing a 2014 Certified EHR System during your entire reporting period. You can obtain your Certified EHR number at: <http://onc-chpl.force.com/ehrcert>, or from your vendor. Below is a chart that shows some sample certification numbers that are used for the various program years. Your 2014 certified system will generate a different certification number from your previous applications.

Program Year	Sample Certified EHR Number	Description
2011 & 2012	A000001CFES9EAB	Original Certified EHR Number
2013	A0H1301CFES9EAB	3 rd through 5 th digits denoted by 'H' and '13'
2014	A014E01CFES9EAB	3 rd through 5 th digits denoted by '14' and 'E'
