To All Vermont Medicaid EHR Incentive Program participants:

WHEN TO ATTEST FOR PROGRAM YEAR 2016

Just a reminder that **MAPIR will NOT allow any applications to be started during a temporary period from 1/1/17 – 1/11/17**. The deadline for ALL PY2016 applications is midnight on **March 31, 2017**. Consult the chart below to see when to start and submit Program Year 2016 EHR Incentive Program applications.
