Scope Definition and Draft Reviews with VITL through April 17, 2023

Submission to CMS for Review by April 17, 2023

CMS 60 Days Review Cycle Ends on June 16, 2023

Contract Execution by June 30, 2023

VITL SFY24 Contract Scope of Work -DDI

Continue to connect Providers to HIE (MDAAP and non MDAAP) - continue to support and promote data exchange by connecting providers to the HIE

Continue Bi-Directional Immunization/EHR work – Connecting Providers and Public Health

Ongoing Enhancements - API development (focus on Providers; Identity Management); enabling SMART on FHIR

Data Quality and Completeness - Improving healthcare outcomes and access for all Vermonters by providing more accurate and comprehensive information to healthcare providers

Placeholder for Potential Development on – Prior Authorization, Complex Care Management, Provider Directory, Data Warehouse

MDAAP

- Phase 1 is underway; Goal is to better understand the HCBS providers and their needs:
 - Provider Survey (active and receiving responses)
 - Focus Group (sessions have been planned)
- Next steps will be to conclude Phase 1 Assessment and focus on Phase 2 Program Design and Implementation Planning.
 - Upon completion of Program Design Deliverable, program administrators will draft up the MDAAP Incentive Payment Protocol.
 - High level overview of the Incentive Payment Protocol will be presented to the Steering Committee for Final Review.
 - Administrators expect this to be presented by Late May or Early June.
- Phase 3 start date to be determined based on CMS approval of the MDAAP Incentive Payment Protocol.

- Next steps are to initiate a kickoff meeting with the stakeholder group and agree on goals for the project


