#### About VITL

- Non-profit organization based in Burlington, VT
- ~26 employees
- VITL is the legislatively designated operator of the Vermont Health Information Exchange (VHIE).



#### Mission & Vision

VITL's **vision** is to be a leader in collaboratively delivering actionable data that leads to better health.

VITL's **mission** is to securely aggregate, standardize, and share the data needed to improve the effectiveness of health care for Vermonters.

Part of a new <u>Strategic Framework</u> introduced in 2021



#### What VITL Does

- VITL collects, translates and standardizes, and matches real-time patient data from health care providers across the state (and beyond) in the Vermont Health Information Exchange.
- Connecting to VITL eliminates the need for organizations to build and maintain multiple point-to-point connections
- Data is made available to inform:
  - Patient care at the point of care
  - Quality improvement
  - Health care reform

- Population health initiatives
- Public health activities

### **VHIE** Data

- Organizations that provide health care can submit data in a variety of formats, including HL7 messages, CCD, CCDA, Fast Healthcare Interoperability Resources (FHIR), or flat files.
  - Admission, discharge, and transfer (ADT) messages
  - Continuity of care documents (CCD)
  - Laboratory results test results and COVID-19 public health reportable results
  - Radiology reports
  - Transcribed reports
  - Immunization messages (including from pharmacies)
  - Home health monitoring
  - Pharmacy fill information from a national network of pharmacies
  - eHealth Exchange patient data to/from a national network



## Data Access / Data Sending Services

#### Data Access Options

- A provider portal, VITLAccess
- Results delivered into EHRs for laboratory, radiology, transcribed reports
- Event notification to meet CMS Conditions of Participation
- Third-party event notification (PatientPing/Bamboo Health)
- Custom views and custom reporting
